**EXECUTIVE ORDER NO. 49**

**AN ORDER REORGANIZING THE INSPECTORATE TEAM OF THE MUNICIPALITY OF ARITAO, NUEVA VIZCAYA.**

**WHEREAS**, part of the General Appropriations Act (GAA) under the FY 2020 Local Government Support Fund (LGSF) is the Assistance to Municipalities (AM) Program, which seeks to equitably assist all municipalities in the delivery of basic services by providing financial subsidy to municipalities for the implementation of their priority programs and projects;

**WHEREAS**, as per DILG Memorandum Circular No. 2019-71, once the project reaches an accomplishment of ninety-five (95%) of the total contract amount, the procuring entity may create an Inspectorate Team;

**NOW THEREFORE, I, REMELINA PEROS-GALAM, M.D.**, Municipal Mayor, by virtue of the powers vested in me by law do hereby create the following:

**SECTION 1. COMPOSITION.** The Inspectorate Team shall be composed of the following:

**SECTION 2. FUNCTIONS.** The Inspectorate Team shall make preliminary inspection and submit a punch-list to the contractor in preparation for the final turn-over of the project in accordance with Section 7 of Annex E of the 2016 Revised IRR of RA 9184.

**SECTION 3. MEETING.** The Inspectorate Team shall hold a regular quarterly meeting, however, the Chairperson may call for an emergency meeting as need arises to discuss problems and issues affecting the implementation of various programs and projects and remedial actions to be elevated to the management committee.

**SECTION 4. FUNDING.** Funds needed to operationalize the Inspectorate Team shall be made available from the General Fund to include the training, capability and other administrative costs.

**SECTION 5. SEPARABILITY CLAUSE.** If any provisions of this Executive Order are declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 6. EFFECTIVITY.** This Executive Order shall take effect immediately.
